- The breeder agrees to furnish the buyers with an accurate pedigree upon delivery of the dog.
- The breeder will withhold registration papers on the above mentioned Dachshund until the buyers furnish proof in the form of a written statement from their veterinarian, on his or her official letterhead, of the spaying or neutering of the above mentioned dog.
